LOOKING AHEAD

**SALARY INCREASES - APRIL 1, 2000**

**Main Unit:** Remember way back when your Bargaining Committee negotiated the last contract?!! Well, the good news is that come April 1st, 2000, we are due for a raise! While individuals' circumstances vary, Clause 28.02(d) on page 75 of the 1997-2001 *Collective Agreement* states that, "Effective April 1, 2000, the salary scale adjustment of 2% shall be applied to the base salaries of members prior to the implementation of career increments." For career increment values within the ranks see details in the salary schedule table at the bottom of page 79, and for details re: your personal half or full increment eligibility see 28.08 (page 80). Also note that come April 1st the overall salary cap is raised to \$98,628. Full professors will also get the remaining 25% of their deferred April 1st 1999, salary scale adjustment, if any (see 2nd paragraph from the top of page 75). **Overload stipends** shall also rise effective April 1, 2000, from \$5594 to \$5704, and TPDA will be increased to \$1,026.

**Collegiate Unit:** UWFA Members in the Collegiate will also experience a 2% scale increase effective April 1, 2000.
